

On September 8, 2019, in our exchange of text messages and emails as shown in Exhibit #1
(found at the end of this petition), Respondent called my friend and me his "enemies" — along
with groundless accusations that I was somehow "threatening" him — and implied that I had yet to see what actions (the possibility of violence cannot be ruled out) he may take next.
On August 13, 2019, Respondent contacted me around midnight and insisted in an intimidating tone that I immediately go to his apartment; I complied, fearful of what could potentially happen to my property (which was still in his custody), my child or me had I not done so. Upon my
arrival, however, he began to demand that I must leave at once — a rather inexplicable and absur
change of mind, indeed — and proceeded to push me outside. Stunned and confused, I started
retreating, only to find part of my hand and leg trapped in the doorway as he continued to
aggressively force the door shut; as a result, still jammed in the door, my finger and foot sustaine injuries, including bruises shown in Exhibit #2.

On July 24, 2019, Respondent and I — still residing together in his apartment at this point —
engaged in a verbal confrontation, which was nevertheless escalated when he forcibly gripped onto and pulled my arm, resulting me falling on the ground. As a result, my arm sustained bruises shown in Exhibit #3.
Describe the past incidents where you experienced violence, where you were afraid of injury or where the respondent threatened to harm or kill you:
There have been numerous instances in which Respondent demanded that I perform sexual acts that I personally find anomalous and unpleasant. Such demands, though not accompanied by direct physical violence, were essentially coercive in nature, for that he threatened to cut off financial support to me and my child had I not complied, while being well aware that I would not perform such sexual acts on my free will, but that I had no choice without compromising my—and more importantly, my child's—well-being.
Emotional abuse, unfortunately, has also been too commonplace throughout our relationship.
Respondent had constantly and persistently called me "a monster," "useless," "stupid," "dumb" and "ignorant," among countless other degrading names, causing me to suffer substantial
emotional and psychological pain, distress and torment.

5 of this Petition due to my initial belief that medical attention did not appear necessary at the
moment, and also to my concerns and uncertainties regarding whether my health insurance —
which was under his name — is still active and usable.
